Presentation Guide for "The Impact of Fraud on the Real Estate Industry"

Program Overview

The PowerPoint presentation is designed to provide PREP Chapter co-chairs a tool to promote a local discussion and gather perceptions about fraud on the real estate industry.

The presentation presents the survey questions and results given to over 8,000 participants in early 2012. The presentation also discusses ways to combat fraud and provides a survey for the local chapters to take at their PREP meeting.

<u>PRIA's Land Fraud Workgroup</u> would like to hear about your meeting and any survey results so they remain aware of the current and evolving effects of fraud.

What can PRIA and PREP members hope to gain from discussing Land Fraud?

- Increased communication and information sharing
- Help to protect the public with decreased local land and mortgage fraud
- Local Success Stories confidence that this problem is being successfully addressed
- Overall willingness to help; the desire to maintain industry integrity is essential

Suggested Meeting Format

- When a survey question appears on the screen, ask the audience to participate by answering the same question with a show of hands.
- Then display the broader survey answers on the next slide and compare the
 national results with your results. You will want to discuss any differences or
 similarities in the responses between your PREP Chapter participants and the
 national survey responses.
- Note that you can also use the survey questions (on a separate document at the end of this document) to refer to or to use in collecting your responses, if you choose. Some groups hand everyone a survey as they enter the meeting room and ask them to complete the survey before the meeting starts.

- How does your group plan to follow-up?
- What additional resources does your group need to combat fraud?
- Would your group like to participate and share ideas regarding fraud prevention by contributing to PRIA's Fraud Resource Center?
- Are there other surveys your group would like to see on any other topics?
